
- (i) The Hon'ble Vice-Chancellor or his/her nominee as Chairperson of the Selection Committee: - **Prof. M. Madhusudan, LIS C**
- (ii) One Expert in the concerned subject nominated by the Hon'ble Vice-Chancellor: - **Prof. Sabaree Mitra, JNU**
- (iii) An Academician representing SC/ST/OBC/Minority/Women/Differently-abled categories nominated by the Hon'ble Vice-Chancellor: - **Prof. B. Murry, Anthropology**
- (iv) Dean of the concerned Faculty; whichever applicable
- (v) Head/Chairperson of the Department/School.
- (vi) At least four members including one outside expert shall constitute the quorum of the Selecting Committee.

You are requested to follow, the Executive Council Resolution No. 267 dated 25.03.2010 followed by University letter dated 10/13.08.2010, 16.07.2013 regarding engagement of guest faculty as already communicated vide this office letter No. Estab.(T)/V/VI/032/2016/Misc./859 dated 06.07.2016 as already communicated vide Estab(T) letter dated 03.07.2017, UGC letter No.F.25-1/2018(PS/MISC.) dated 28th January 2019.

The Guest Faculty will be paid honorarium of Rs. 1500/- per lecture subject to a maximum of Rs. 50,000/- per month, as per UGC letter No.F.25-1/2018 (PS/MISC.) dated 28th January 2019.

After completing the process, the recommendations of the Departmental Selection Committee alongwith all the relevant documents (in original) i.e. "Minutes of the Selection Committee", "Attendance Sheet of All candidates & Summary of Selected Candidates with essential eligibility detail & CV of Selected candidates duly authenticated, be sent to this office for consideration and approval of the competent authority of the University.

Further, your request for the appointment of Ad-hoc Assistant Professor has not been acceded to.
